Early breakdowns will affect your approval for future events with Pop-Up Marketplace Las Vegas.
- Business Owners are required to be on time and remain until the end of the event. We are not responsible for lost or stolen items.
- Each vendor will be provided (1) covered six foot table and chair(s). You may bring an extra table and accessories to create an inviting retail space. If you are bringing an extra table, please make sure the linen is black so that everything remains uniformed.
- You are solely responsible for your area; do not leave it unattended.
- Event organizers have no control over the attendance of the vendors/guests or promise any specific results in regards to this event. Please feel free to invite your customer base to promote attendance.
- Raffles will be conducted before the end of the event. Please make sure your item has your business card/information attached.
- Vendors are allowed to park by the entrance to unload. Please be mindful of others who will be unloading as well.
- Each vendor is responsible for keeping their booth area neat and clean at all times. You are responsible for any trash accumulated and must dispose of it properly.
- Must have a valid business license and a State of Nevada Sales Tax Permit.
